

Skilled Immigrant Integration Program Request for Proposals

Overview

WES Global Talent Bridge's Skilled Immigrant Integration Program (SIIP) offers communities an opportunity to leverage technical assistance (TA) from WES and its national partners and join a network of communities to further their state and local skilled immigrant integration initiatives.

WES Global Talent Bridge seeks communities committed to accelerating the creation and expansion of tested and promising approaches to immigrant professional integration. This program will provide high potential communities with customized training, coaching and technical assistance to advance concrete initiatives and build sustainable networks to advance local skilled immigrant integration efforts.

This opportunity is intended to serve local communities already engaged in supporting immigrant professional success through local programs and initiatives.

Selected communities will receive:

- 12 hours of coaching and advising (per community) provided by WES Global Talent Bridge
- 12 hours of additional customized technical assistance (per community) from national experts (see list of TA provider and their areas of expertise attached)
- Sponsorship for 3 delegates to participate in a convening in Toronto, Canada (spring/summer of 2019); WES Global Talent Bridge will fully reimburse all travel and lodging costs
- Four interactive web-based training sessions with WES Global Talent Bridge and other national partners on topics related to skilled immigrant professional integration
- Monthly calls with WES Global Talent Bridge and participating states and/or cities to share ideas and provide updates on the progress of local efforts
- A platform to regularly collaborate with peers on immigrant professional integration

Program Criteria and Expectations

Communities must commit to engaging fully in the training and technical assistance provisions outlined above. Communities will be expected to exchange ideas, share best practices, and learn from TA providers and other communities participating in the program.



Selected communities must demonstrate meaningful participation in a robust network of multi-sector stakeholders with a strong commitment to continue engaging as a community of practice after the conclusion of the program.

The network should include at least one stakeholder from each of the following categories:

The program will require a lead organization to take responsibility for coalescing, convening, and supporting the work with WES Global Talent Bridge and the other TA providers.

Applications with a lead agency anchored in local government will receive preference.

- Each community will commit to achieving 2-3 outcomes over the course of the year that will advance skilled immigrant integration efforts locally. These outcomes can center around (but are not limited to) workforce and/or ESL provision, public education, expanding multi-sector partnerships or improving local policies. Examples of outcomes from the previous program year included:
 - Developing career pathways resources for internationally-educated immigrants
 - Developing employer engagement strategies
 - Strengthening local and regional partnerships
 - Engaging community colleges in skilled immigrant integration
 - Developing strategies to address local and state policy
 - Developing workforce development strategies to better serve skilled immigrants



- Creating public education campaigns and convenings to raise awareness
- Selected communities will be required to participate in all program activities including monthly calls, quarterly training, and the in-person convening in Toronto.
- Communities must also agree to participate in a rigorous program evaluation process over the course of the program, including participation in focus groups, submission of program logs and quarterly check-ins.

Project Timeline and Support

WES Global Talent Bridge will select a limited number of communities for this program. The provision of training and technical assistance will begin in January 2019 and end December 2019. Customized technical assistance from WES Global Talent Bridge and national partners can be accessed throughout the year as mutually agreed by the communities and the TA providers. TA is limited to 24 hours per community (12 hours from WES Global Talent Bridge and 12 additional hours from one or more of the national partners). In addition to the customized technical assistance, communities will receive support and coaching through monthly calls and trainings. Finally, WES Global Talent Bridge will reimburse travel and lodging expenses for 3 delegates to attend a three-day convening in Toronto in the late spring/early summer of 2019. Communities must send a delegation to the convening.
